

## Snapshot of Textile and Clothing trade data in WTO report 2011 (with statistics for 2010)

### World Textile & Clothing (T&C) Exports

- World T&C exports grew by 14.6%, from USD 525 billion in 2009 to USD 602 billion in 2010.
- Vietnam (20.3%), China (14.8%), Bangladesh (12%), Turkey (7.8%) and India (7.6%) are among top-5 countries to have higher annualized growth rates (CAGRs) than world's CAGR of 5.5% during a decade of 2000 to 2010.
- China has increased its share in world exports from 14.8% to 34.3%, India from 3.3% to 4.0%, Turkey from 2.9% to 3.6%, Bangladesh from 1.6% to 2.8% and Vietnam from 0.6% to 2.2% during 2000-2010.
- Under country-wise profile, India is now second largest supplier of T&C products in world after China. Chinese share was 34.3 % during 2010. It grew by 23.7% in 2010. India has achieved second slot with world share of 4.0% and it grew by 14.2% during 2010.
- India recorded a 41.3% increase in its exports of textiles in 2010 to become the third-largest exporting nation, just ahead of the United States.
- Among the major exporters of clothing, India registered a decline of 6.3 % in 2010.
- China became the major exporter of textiles in 2010, pushing the European Union into second place.
- China's share in world exports of clothing increased to 37 per cent in 2010, rising from 18.3 per cent in 2000, while its share in the country's total exports declined to 8.2 per cent, from 14.5 per cent in 2000.

## World Textile Exports

- World textile exports grew by 19.5%, from USD 210 billion in 2009 to USD 251 billion in 2010.
- Vietnam (24.5%), China (16.9%), Turkey (9.3%), India (8.7%) and Thailand (6.7%) are among top-5 countries to have higher annualized growth rates (CAGRs) than world's CAGR of 4.9% during a decade of 2000 to 2010.
- China has increased its share in world textile exports from 10.4% to 30.7% , India from 3.6% to 5.1%, Turkey from 2.6% to 3.6%, Vietnam from 0.2% to 1.1% and Thailand from 1.2% to 1.5% during 2000-2010.
- Growth-wise top-5 countries for textile exports are India (41.3%), Vietnam (32.4%), Indonesia (29.4%), China (28.5%) and Thailand (25.3%) in 2010.

## World Clothing Exports

- 80% of World clothing exports shipped to developed countries in 2010.
- World Clothing exports grew by 11.4%, from USD 315 billion in 2009 to USD 351 billion in 2010. Vietnam (19.5%), China (13.7%), Bangladesh (11.9%), Turkey (6.9%) and India (6.5%) are among top-5 countries to have higher annualized growth rates (CAGRs) than world's CAGR of 5.9% during a decade of 2000 to 2010.
- China has increased its share in world clothing exports from 18.3% to 36.9% , Bangladesh from 2.6% to 4.5%, Turkey from 3.3% to 3.6%, India from 3.0% to 3.2%, Vietnam from 0.9% to 3.1% during 2000-2010.
- Growth-wise top-5 countries for clothing exports are Vietnam (26.9%), Bangladesh (25%), Malaysia (24.1%), China (21%) and Pakistan (17.1%) in 2010. India is only country to have negative growth among major clothing exporters in 2010.
